Please find enclosed herewith a copy of the vacancy circular for the post of Administrative Officer on deputation basis under composite method of recruitment. The appointment of the above post will be on deputation terms and on purely temporary basis initially for a period of one year which shall ordinarily not exceed three years. On appointment the pay of the official will be regulated in accordance with the M/o Personal, Public Grievances & Pensions, Deptt. of Personal & Trainings O. M. No. 2/29/91-Estt. (Pay-II) dated 5.1.1994 read with No. 2/8/97-Estt. (Pay-II) dated 11.3.1998.

(b) Possessing the following educational qualification and experience-

(i) Bachelor Degree in any discipline from a recognized University or equivalent.

(ii) 5 years' experience in Establishment, Administration and accounts matter

(iii) The Departmental officers/officials in the pay grade of Rs.4600/- (Rs.6500-200-10500/-pre-revised) of the Commission with three years regular service in the grade shall also be considered along with outsiders. In case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

(iv) The Departmental officers in the feeder category, who are in the direct line of promotion, will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.
