

## **Success Story**

**Issue/Problem: - The traffic problem at S.G. Balekundry junction abutting the compound wall of the Parsi Fire Temple**

Dr. H T Sangliana, Vice Chairperson, NCM visited Bangalore, between 5th and 8th August, 2011. During his tour, he inspected the Parsi Fire Temple in connection with complaint of the Parsi leaders regarding difficulty of accessibility to the Fire Temple through the Entry and Exit gates due to traffic congestion, etc.

Dr. Sangliana suggested for fixing signages like "No Stop" and "No Parking" at the sites and manning of the functions by traffic constables and regular spot visit by traffic officers. In this connection Dr. Sangliana spoke to the Deputy Commissioner of Police -Traffic and advised him in the matter which was effectively attended to. In this context, Dr. Sangliana also wrote a letter on 16th August, 2011 to the Deputy Commissioner of Police -Traffic in confirmation of the suggestions that he gave orally.

The advice yielded positive results and the congestion near the Parsi Fire Temple premises has considerably improved now. A letter of thanks was received from the Bangalore Parsi leaders and hence this success story.

I wish to inform you that thanks to your visit the congestion near our Fire Temple premises has been reduced considerably.


