- 20. Agenda Item No. 16: Any other item with the permission of Chairman:
  - (i) Member (MSR) raised the issue of non-awareness of minority schemes at district level. The Commission was informed that the office has already written letters to all districts in this regard. It was desired that another letter to Chief Secretaries may be written alongwith a request to allocate separate fund for advertisement of schemes for minorities. In this regard, Chairman desired that NCM may conduct awareness programme in all MCDs or at least one district in each State. It was decided to write to MoMA to allocate budget of Rs. 3 lakhs per district for this awareness programme. Member (KKD) also suggested that some Members together may visit each district every fortnight for this purpose.
  - (ii) Member (SK) informed that many students face difficulty while applying for scholarship schemes online. The Common Facility Centres at District level may be requested to provide information about scholarship and other schemes and facilities available for minorities.
  - (iii) Commission desired that the website of NCM may be updated at the earliest and all the information should be uploaded from time to time which is not being done right now.
  - (iv) Member (SK) desired that the Commission may visit Nagpur on 11<sup>th</sup> or 12<sup>th</sup> of April, 2020 and have a meeting.
  - (v) Member(SK) desired that letters may be sent for making proper connectivity for Buddhist tourist places.
