1) It was felt that functioning of the Commission has been diverted over the years from the very purpose for which the Commission was constituted. Accordingly, the Legal Consultant may prepare a report in this regard under the guidance of Chairman/Members so that Commission can function more effectively.

2) Chairman desired that Research Scholars including a Professor level person may be engaged by the Commission from Recognised Research institutions/Universities for a period of 6 months for carrying out the studies starting with Inter-faith unity/co-ordination. The appointed team may work under the supervision/guidance of Vice Chairman/Members.
