#### 7.Confirmed.

- Regarding the book on different religion, it was decided to hire a professional through advertisement preferably a PHD holder on Inter-faith Religion or pursuing PHD in the same subject, for three months initially which can be extended. Information on Jews & Hindus may also be included in the book.
- Regarding the issue of study on socio-economic conditions of Jains, Chairman
  desired that initially information may be obtained from all States on different
  parameters (to be decided by Member (DJG)). Based on this basic information,
  the Commission will further decide to conduct the study.

- On the tour of Member (SS) to Bihar, Chairman desired to see the files in which letters were written to Government of Bihar.
- Regarding inputs to be forwarded to NCMEI, an interim reply may be sent informing that a Committee has been constituted in the Commission and material will be sent shortly.
- Regarding the file of Gurudwara Baba Buddha Sahib, Uttam Nagar, Chairman desired that D.O. letter may be sent to Minister of Road Transport & Highways, for considering the matter.
- An Iftar Party may be organized on 28.04.2022 evening. M(SS) will give the list of invitees to be called for the function which may include Vice Chancellor of Universities, Scholars, Religious leaders. Press will also be invited for the function.
- Regarding issuance of Minority Certificate, it was decided that Legal Consultant
  may discuss the issue with Secretary, NCM, to formulate a policy which may be
  recommended to all States. This may include mention of religion in the Birth
  Certificate or Aadhar Card. Accordingly, letter may be written to Ministry of Social
  Justice & Empowerment for implementation of this all over India uniformly.
