A meeting of the National Commission for Minorities was held at 11:00 A.M. on 29^{th} December, 2021 in the Conference Room.

- 5. The Commission noted the leave of absence of Sh. Deboo. However, Hon'ble Chairman directed that absence of Chairman, Vice-Chairman or Members may be intimated to the Commission at least 3 days before the meeting unless it is a medical emergency.

Agenda Item No. 1: Confirmation of the record notes of the Meeting of the Commission held on 26.11.2021.

Agenda Item No. 2: Tour Report of Shri Kersi K. Deboo, Member to Gandhinagar, Gujarat on 3rd December, 2021.

Supplementary Agenda No. 1: Joint Meeting related to Education of Minorities

8. Commission was informed that the meeting is tentatively scheduled on 10.01.2022 which will be chaired by Minister of State (Education). It was decided that Secretary, NCM or Joint Secretary could attend the meeting. The Commission would be informed about the outcome after the meeting.

Supplementary Agenda No. 2: Drawback in the present system of Minority education

9. The Commission was informed that 2 studies are proposed to be carried out viz. (i) Comparison of schemes under M/o Social Justice & Empowerment and M/o Minority Affairs (ii) Educational Development of Minorities. Files are being put up in this regard. The matter of low income limit for parents for different scholarship schemes was also discussed. Due to the low income limit, students belonging to Jain, Sikh and Parsis are not getting benefits of the schemes. The Commission decided that Ministry may be requested to revisit the income limit of parents under different schemes as well as bring them at par with similar schemes of other Ministries.

Supplementary Agenda No. 3: Preparation of book on Religious Minorities

10. The Commission was informed that a book containing details of all religions will be published by NCM containing 30-35 pages of each religion. This would consist of history, belief and rituals of all religions. The Members were requested to gather material with respect to their religion in this regard and provide to the Commission for further necessary action.

Supplementary Agenda No. 4: Grantee Status for NCM

11. Secretary, NCM explained the background behind Grantee Status of NCM. It was decided that the Commission will soon meet Hon'ble Minister of Minority Affairs in the matter regarding continuation of status of the present staff.

However, in practicality many States do not follow the laid down order and proper protocol/ security is not provided to the Chairman, Vice-Chairman and Members as in recent instance of appropriate protocol not being provided to Vice-Chairman during his visit to Aligarh, UP. Secretary, NCM informed that he would take up the matter with concerned Chief Secretaries. It was also decided that a letter may be written to PMO and MHA with a copy to MoMA so that an advisory may be issued to all States regarding the status of Chairman, Vice-Chairman and Members of the Commission, reiterating the status given in 1978 order.
