



Chairman, NCM is nominated by the Central Government under Section 3(2) of the NCM Act,1992. The term is of three years.

Justice Mohd. Sardar Ali Khan, the first Chairman of statutory Commission, was nominated on 05.07.1993.

After him, 9 persons of eminence were appointed as the Chairperson of the NCM.



Meeting with Sikh Community 9th October, 2024

- A meeting was chaired by Shri Iqbal Singh Lalpura with eminent Sikh representatives.
- More than 50 eminent Sikhs, retired Generals and Senior armymen, lawyers, industrialists, academicians, members of ex-royal families etc participated.
- Meeting was aimed to promote wider dialogue and consultation for understanding the key issues and to recommend the way forward for further development of the Sikh Community.

Deliberations:

- On efforts for promoting and conserving Sikh history, heritage and culture.
- Mitigation of border challenges through strong border focused programme in Punjab.
- Focus on agriculture through soil revival, value addition of produce, promoting precision farming and mechanisation.
- Strong Youth development and empowerment programme.
- Issues pertaining to Gurudwaras and its management.
- Engagement with Industry and promotion enterprise.
- More effective communication strategy and developing positive narrative and role models for the youth.

Education



- Strengthen Education inputs from School to Higher Education.
- Improve STEM representation and provide Skill Certification.
- Support increased representation in Public Service.



7th NCM Meeting 2024 - 25

- 7th NCM meeting was held on 16th October, 2024.
- Reviewed work done and the key activities for September, 2024.
- Approved technical support for institutionalisation of organisation of various events, meetings, seminars and consultations.
- Detailed presentation on focus State Uttarakhand.

Important discussions:

- Need for basic standards on safety, security, sanitation and amenity at the religious places.
- Provision by the State Governments for safety and facilitation of passing of the Jain Saints during Vihara.
- Proposal for changing the name of Lawrence Road to Maharaja Ranjit Singh Road, Amritsar.
- To study the archival details of debates and composition of management in Mahabodhi Temple Management Act, 1949.

Chairman Shri Iqbal Singh Lalpura and Member Rinchen Lhamo visited Bodhgaya.

Buddhist Monks requested for allowing only Buddhist Community to manage the Mahabodi Temple complex.

Discussion Points

- Study adequacy of representation of Sikh history and contribution of Sikh Gurus and warriors to the national integration in the school curriculum.
- Petition of Dharmi Fauji Association for pension enhancement, health and canteen coverage to Sikh Army Deserters.
- Further discussion on extending the facility to for more pick ups of Haj Pilgrims, particularly for the persons coming from remote districts.
- · Promotion of Prakrit Language and other languages such as Gurmukhi, Urdu.

- Jiyo Parsi is a uniqe Central Sector
 Scheme for arresting the population
 decline of the Parsi Community.
- The scheme was launched in 2013-14.
- The objective of the scheme is to reverse the declining trend of Parsi Population by adopting scientific protocol and structured interventions to stabilize their population in India.
- The scheme has three components, Medical Assistance, Advocacy & Health of Community.

Uttarakhand Commission for Minorities Act, 2002

- The Uttarakhand Minority Commission Bill, 2002 passed by the Uttarakhand Legislative Assembly under Article 200 of the Constitution of India was assented to on 16.06.2002.
- Uttarakhand Minorities Commission has its headquarter at Dehradun.
- The State commission has posts of Chairman, two Vice-Chairmen and nine Members including a woman from minorities.
- At present there are two members i.e Shri Parminder Singh and Mohd. Tasleem.



Status of NCM Grievances in the State

NCM has received 52 grievances in 2023-24.

35 grievances are awaiting reports and resolution.

Action Taken report on NCM recommendations is awaited.

Key Suggestions of NCM

- Early resolution of allotment of land to Gurudwara Gyan Godri at Hardwar which was demolished in 1978.
- Reports of Communal disturbance be forwarded regularly.
- Publicity of Central and State
 Government Schemes for the welfare of the minorities.
- Earmarking of land for cremation to Buddhists, wherever requested.
- Strengthening of the State Minority Commission and making it fully functional.

NCM in Uttarakhand



- NCM had visited Uttarakhand twice in 2023-24.
- Commission visited in Feb, 2024 mainly to resolve issue of Gurudwara Gyan Godri.

Impact of NCM in Grievance Resolution

- In October, NCM has received 414 grievances.
- In this month 150 grievances were settled.
- NCM stressed on the need for early resolution of 872 grievances pending for more than 3 months.

Hearings under Section 9(4) (a) of the NCM, Act



Commission acknowledged Ms. Panzy Rumy Dastoor's Agricultural Land Deprivation Case.

- Land acquired in 1958, claimed to be barren.
- Petitioner claims no compensation from Railways was recieved.
- Railways directed to produce payment records.

IMPACT OF NCM



Case of Shri Karan Singh from Nepal Army

- A Sikh soldier working for Nepal Army was dismissed as he refused to shave beard and cut his hair.
- NCM took suo-motu cognizance of post dated 20.09.2024 on X regarding the issue and communicated through Ministry of External Affairs to take up the matter with the Nepal Government.
- Ministry of External Affairs informed that the issue has been resolved and Shri Karan Singh has joined the Nepal Army.

Case of Guthka Sahib in Perth, Australia

- A foreign national was involved in desecration of the Gutka Sahib in Perth, Australia.
- The NCM took suo-moto cognizance of the incident and took up the matter through Ministry of External Affairs.
- The Ministry of External Affairs informed that miscreant tried to incite hatred among various communities but could not succeed.
- Following investigations, the western Australia Police arrested the miscreant and was subsequently released by local court with the direction to do community service for six months.
