
The Commission shall perform all or any of the following functions, namely:--

NATIONAL COMMISSION FOR MINORITIES

- Evaluate the progress of the development of minorities under the Union and States;
- Monitor the working of the safeguards provided in the Constitution and in laws enacted by Parliament and the State Legislatures;
- Make recommendations for the effective implementation of safeguards for the protection of the interests of minorities by the Central Government or the State Governments:
- Look into specific complaints regarding deprivation of rights and safeguards of the minorities and take up such matters with the appropriate authorities;
- Cause studies to be undertaken into problems arising out of any discrimination against minorities and recommend measures for their removal;
- Conduct studies, research and analysis on the issues relating to socio-economic and educational development of minorities;
- Suggest appropriate measures in respect of any minority to be undertaken by the Central Government or the State Governments;
- Make periodical or special reports to the Central Government on any matter pertaining to minorities and in particular difficulties confronted by them; and
- Any other matter which may be referred to it by the Central Government.


Discussion with the States



Abhidhamma Divas

- Abhidhamma Divas commemorates the day when Lord Buddha descended from the celestial realm, Tāvatiṃsa-devaloka, to Sankassiya (now Sankisa Basantapur) in Uttar Pradesh.
- The Ashoka Elephant Pillar, a historical marker at the site, marks this significant event.
- According to Theravāda Buddhist texts, Lord Buddha spent three months teaching the Abhidhamma (Higher Teachings) to the deities in Tāvatimsa, including his mother.
- It coincides with the recognition of Pali as

 a classical language and represents a
 significant stride in India's efforts to
 preserve and promote Buddhism's rich
 legacy.

8th NCM Meeting

- 8th NCM meeting was held on 20th November, 2024.
- Approved professional service support in publishing reports, studies and newsletter.
- Approved two State Annual Awards for the State Minority Commissions performance.

Approved embedding of National Clearing House for data management

Deliberations

- Recent Supreme Court Judgements (three) were studied in the meeting.
- RBI report on Credit facilities to MInorities Community for 2023-24 were discussed. It was noted that amount of lending and total number of loan accounts have increased in Minority Concentration Districts.
- PLFS data regarding emplyoment amongst minorities was also deliberated. The interfaith differentials were discussed and more insight was sought on these.

Research and Data Analysis Division



A new Research and Data Analysis Division was approved to fulfill NCM Mandate under section 9(1) (a), (b), (e) & (f).

It will professionalise the way NCM manages the data and undertakes research.



Visits of Commission

Meeting of Shri Kersi K. Deboo, Vice Chairman with District Collector and SP of Valsad District, Gujarat on land issues of Parsi Community.

NCM has also issued an advisory to the Chief Secretary, Gujarat for increasing due diligence to restrict any fradulent land transfers of Parsis.

Shri Kersi K Deboo, Vice-Chairman and Ms. Rinchen Lhamo, Member held discussions with Lakshadweep Private Tourism Sector (LTDA) in Agatti, Lakshadweep.

Discussion Points

- Need to Strengthen State Minorities Commission in 18 States and establishing State Commissions in the remaining States where the Act is not enacted.
- Improving education facilities to the minority communities.
 - Standardising and providing basic facilities at the minority pilgrimage sites.
 - Harnessing the potential of tourism to increase employment in minority pilgimage towns.


Punjab State Commission for Minorities

- The Punjab State Commission for Minorities Act, 2012 was passed by Punjab Legislative Assembly under Punjab Act No. 13 of 2013.
- This was assented to the Governor of Punjab on the 1st February, 2013.
- The Headquarters of the Commission shall be located at Ajitgarh (Mohali).
- The Commission shall consist a Chairman with five non-official members from the Minorities.

NCM Grievances in the State

NCM has received 129 grievances in 2023-24.

71 grievances are awaiting reports and resolution.

Action Taken report on NCM recommendations is awaited.

Key Suggestions of NCM

- To submit a strategic approach to address the growing need for a focused media campaign against the possible misrepresent cultural and religious values in the youth with the aim at combating misinformation and promoting positive role models for Sikh youth in Punjab.
- Inclusion of history and contribution of Sikh Gurus and Warriors in the School Education and National Curriculum Framework – to make a presentation to collaborate the initiative.
- To change the name of Lawrence Road to Maharaja Ranjit Singh Road in Amritsar.
- To take necessary action for taking steps on skilling, knowledge and technology transfer for food processing for value addition in agriculture.
- To consider starting a State funded coaching and career development programme for improving representation of minorities in Public services including All India Service, Defence and Paramilitary services.
- To invite multi-national companies to enhance youth empowerment through training and mentorship which would provide job opportunities for the youth.

Impact of NCM: Grievance Redressal

- The Commission took suo-motu cognizance of the matter of the pending compensation for the families affected by the 1984 anti-Sikh riots.
- Following the approval of the Lieutenant Governor, Shri V.K. Saxena, appointment letters were issued to the eligible families.
- The Delhi government has relaxed job norms by providing age and educational concessions for the families of the 1984 riot victims.
- Additionally, it has announced a drive to hold camps for the remaining families.

Benefit of NCM in Grievance Management

- In November, NCM has received 424 grievances.
- In this month 768 grievances were disposed off.
- NCM stressed on the need for early resolution of grievances pending for more than 3 months.
