SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR TENDERS

- The NCM located at Block-III, Ground & 3rd Floor, CGO Complex, Lodhi Road, New Delhi-110003, requires the services of reputed well established and financially sound companies/Firms/ Agency/Proprietor for award of Annual Maintenance Contract for the maintenance of EPABX system installed in the NCM.
- 2. The contract will be initially for period of one year. The period of the contract may be further extended provided the requirement of the Commission persist at that time or may be curtailed, terminated earlier owing to deficiency in service or substandard quality of service.
- 3. The bidder that is awarded the contract will ensure that complaints regarding breakdown of EPABX system are attended to on the very same day. In case of any delay, the firm will intimate the Commission for delay with sufficient reasons. The firm will also undertake pre-emptive servicing of all the EPABX/Switches assigned at least once in a month. The firm should be responsible to maintain the proper line connectivity of the MTNL line from last end of the supply by MTNL (near the VIP lift at ground floor) up to user's instruments.
- The interested Companies/Firms/Agencies/Proprietor can submit the tender documents complete in all respects along with EMD of Rs.10,000/- and other requisite documents and deposit the same at the NCM.
- 5. The EMD of Rs. 10,000/- refundable (without interest), should be necessarily accompanied with bid of the bidder in the form of Demand Draft/Pay order drawn in favor of DDO, NCM, New Delhi, along with required documents. The priced bid should be kept in a sealed envelope along with these papers in the main envelope. This is to avoid making quoted public rates in case of non-submission of essential documents.
- 6. The successful bidder will have to deposit a performance security deposit of Rs. 15,000/- (Rupees Fifteen thousand only) in the form of Fixed Deposit Receipt (FDR) made in the name of the bidder but hypothecated to the DDO, NCM, New Delhi for a period of 15 months. In case, the contract is further extended beyond the initial period, the FDR will have to be accordingly renewed by the successful bidder.
- 7. The Bidder is required to enclose photocopies of the following documents (self-attested), along with the technical Bid, falling which their bids shall be summarily/out-rightly rejected and will not be considered any further for price bid:-
 - (a) Self-attested copy of PAN
 - (b) Self-attested Service Tax Registration letter/Certificate;

- (c) Self-certified copy of GST certificate;
- (d) Self-Certification to the effect that the firms has not been banned/black listed by any Ministry/Department in the past.
- 8. The agency should have at least 3 years' experience in maintenance of EPABX during last 5 years ending 31.03.2021, preferably in Govt. Department / PSU's.
- Agency should have average financial annual turnover of at least Rs. 5,00,000/during last 3 years ending 31.03.2021. Copy of profit/Loss Account, Balance Sheet or Income Tax Return may be submitted towards proof of annual turnover.
- 10. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Bid Application in the Bid Form. In such cases, the tender shall be summarily rejected. However, the cuttings, if any, in the Bid Application must be initialed by the person authorized to sign the tender's bids.
- 11. The Commission reserves the right to withdraw/cancel the tender process without assigning any reason.
- 12. The price quoted by the Bidder participating in the tender process should be realistic and viable. In case two or more firms have quoted same rates, the contract will be awarded to the firm with greater experience and having its offices at less distance from the office of NCM.
- 13. The bidder should filled the following technical requirements:
- (a) The Registered/Branch Office of the bidder should be located in Delhi/New Delhi/NCR.
- (b) The bidder should register with the appropriate registration authority for bid work.
- (c) The bidder should have its own Bank Account.

TERMS & CONTITIONS

1. The contract is likely to be a period of one year unless it is curtailed or terminated by this Commission owing to deficiency of service, Sub- standard quality of service provided, breach of contract, etc.

2. The contract shall automatically expire unless extended further by the mutual consent

of contracting agency and this Commission.

3. The contract may be extended, on the same terms and Conditions with some addition / deletion / modification, for a further specific period mutually agreed upon by successful service providing Company/Firm/Agency/proprietor and Commission.

4. The bidder shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency without the prior consent of this

Commission

5. The bidder will be bound by the details furnished by him to this Commission, while submitting the tender or at subsequent stage.

6. The consumable supplied should be genuine and manufactured by the original equipment manufacturer. Supply of spurious consumables will invite penal action including termination of the contract and blacklisting/banning of the firm.

7. The contract terms are interpretable under the applicable Indian Law subject to the

jurisdiction of NCT of Delhi.

8. The Bid should be accompanied with an EMD, refundable, of Rs.10,000/-(Rupees Ten thousand only) in the form of Demand Draft/Pay order drawn in favour of DDO, NCM, New Delhi failing which the tender shall be rejected out rightly.

9. Evaluation of the Bide: Technical Bid shall be opened in the presence of the bidders or their authorized representative at scheduled time and date. The Bidder who submit all the documents mentioned will be considered as technically qualified and

considered for opening the price Bid.

- 10. The Price Bid will only be opened afterwards in presence of their authorized representatives on a suitable date and time which will be intimated to the technically eligible bidders in due course through Letter/Fax/Telephone/e-mail. Bidder who will quote the lowest rate for the tender will be awarded the job subject to the fulfillment of all other terms and conditions of the tender. Tenders containing overwriting, correction or erasing, without authentication with full signature on the page(s) of "Price Bid" and amount/ quantity not shown in figures and words will be liable for rejection. Submission of the price-bid in a format other than the requisite format may be liable for rejection by the Tender committee. In case there us any discrepancy between figures and words, then the amount quoted in words will be considered for evaluation. The L-1 bidder will be evaluated on the basis of lowest quoted rate in the price bid
- 11. The EMD in respect of the unsuccessful agencies shall be returned to them without any interest.
- 12. Award of contract shall be made at the absolute discretion of NCM. The NCM reserves the right to reject any part or whole of the tender without assigning any reason whatsoever. For such cancellation the bidders shall not be entitled to claim any cost, charges, expenses incidental to or incurred by him through or in connection with the preparation and submission without assigning any reason whatsoever.

- 13. NCM shall not be liable for any delay in receipt of the tender document by the bidders due to postal delay and no extension of time to the date of tender opening shall be given for this reason.
 - 14. The successful bidder will have to deposit within 5 days, a Performance Security Deposit of Rs.15,000/- (Rupees Fifteen thousand only) in the form of Fixed Deposit Receipt made in the name of agency Hypothecated to the DDO, NCM, New Delhi covering the period of contract. In case, the contract is further extended beyond the initial period, the FDR will have to be accordingly renewed by the successful bidder.
 - 15. The agency shall submit the quarterly bill in triplicate after completion of each quarter (3, months). Payment shall be made through RTGS/NEFT on submission of necessary details of Bank A/c No., IFSC code, Branch, etc. Income Tax Education Cess and other taxes as applicable shall be deducted at source at the rate prescribed in the income tax Act and /Or any other relevant Act from the gross value of each monthly bill.
 - 16. In case of breach of any terms and conditions attached to this contract, the Performance Security Deposit of the agency will be liable to be forfeited by this Commission besides termination of the contract.
 - 17. The agency shall be fully responsible for any loss / damage that may be caused to the premises, equipment, machinery, and other installation of the NCM in the course of any carrying out the job by him, and the agency is fully liable to reimburse the cost of such damages to NCM. NCM fully reserves the right to recover the cost of such damages including recovery from any sum due to the agency.
 - 18. The Commission reserves right to withdraw/relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
 - 19. Any dispute or difference under or arising out of or in respect of the agreement may be referred for arbitration for a person appointed by the Secretary(NCM), CGO Complex, Block-3 3rd Floor, Lodhi Road, New Delhi-110003 and his decision in the matter will be final and binding on the agency and company. The arbitration shall be carried out as per Arbitration Act, 1996 and Rules made there under as amended from time to time.
