Notice Inviting Tender (NIT) for conducting studies for National Commission for Minorities (NCM)

1. National Commission for Minorities

The National Commission for Minorities was set up as a statutory body with the enactment of the National Commission for Minorities Act, 1992 by the Parliament. NCM Act, 1992 extends to the whole of India. The Act was enforced with effect from 17.5.1993 and amended on 8.9.1995 to provide for a Vice Chairperson in the Commission. As the Act stands after the amendment in 1995, the Commission now consists of a Chairperson, a Vice Chairperson and five Members, out of which 5 Members including the Chairperson shall be from amongst the notified religious minority communities.

2. Definition of Minority

As per Section 2(c) of the NCM Act, 1992, 'Minority', for the purposes of the NCM Act, means a community notified as such by the Central Government. The functions and responsibilities of the Commission are thus related to the six notified minority communities based on religion namely, Muslims, Christians, Sikhs, Buddhists, Parsis and Jains.

3. Functions of NCM

As per Section 9(1) of the NCM Act, 1992, the Commission is required to perform following functions:-

- (a) evaluation of the progress of the development of minorities under the Union and States;
- (b) monitoring of the working of the safeguards for minorities provided in the Constitution and in laws enacted by Parliament and the State Legislatures;
- (c) making recommendations for the effective implementation of safeguards for the protection of the interests of minorities by the Central Government or the State Governments;
- (d) looking into specific complaints regarding deprivation of rights and safeguards of minorities and taking up such matters with the appropriate authorities;

- (e) getting studies to be undertaken into the problems arising out of any discrimination against minorities and recommending measures for their removal;
- (f) conducting studies, research and analysis on the issues relating to socio-economic and educational development of minorities;
- (g) suggesting appropriate measures in respect of any minority to be undertaken by the Central Government or the State Governments;
- (h) making periodical or special reports to the Central Government or any matter pertaining to minorities and in particular the difficulties confronted by them; and
- (i) any other matter, which may be referred to it by the Central Government.

4. Scope of Work

- 4.1 NCM intends to engage the agencies for conducting the following studies:
- (i) "Comparison of Welfare Schemes of Ministry of Minority Affairs and Ministry of Social Justice & Empowerment"
- (ii) "Educational Development of Minorities"
- 4.2 Objective and Terms of References

The Objective and Terms of References for the studies mentioned above are as per Annexure I.

5. Eligibility of the Agency

- (a) The agencies should be well experienced in conducting such kind of studies and well versed with the subject.
- (b) The agency should have a minimum three years' experience in conducting such evaluations/ studies at various levels National/ State/ District Levels.
- (c) The agency should have executed at least one similar project for Central/State Govt. departments/organizations.
- (d) Should have a minimum average annual turnover of Rs. 30.00 Lakhs (Rupees Thirty Lakhs) during the last **three years**, to be supported by audited Balance Sheets, P/L A/c, Receipt and Payment A/c.

- (e) Should have adequate technically and managerially qualified and well experienced inhouse resource base and a strong creative team for designing and implementing the studies.
- (f) The agency should have the ability to collect relevant data/information required for the purpose without imposing any responsibility on NCM.
- (g) The applicant must have G.S.T. registration and should be income tax assesse.
- (h) The applicant should furnish an undertaking to the effect that the firm has not been black listed in India or abroad by any Government department/agency.

6. EMD & Submission of Bids

Stage II : Evaluation of Financial Bid

The methodology of financial evaluation will be as follows:

- (a) The lowest price quoted in all the financial bids would be denoted as L_1 and would be given the score as '50 points'
- (b) The price quoted by firm 'A' would be termed as 'La' and the score obtained would be Score = (L_1/L_A) *50 Points

Final Evaluation
