सा.का.िन. 783(अ).—केंद्रीय सरकार, राष्ट्रीय अल्पसंख्यक आयोग अधिनियम, 1992 (1992 का 19) की धारा 15 के उप-धारा (2) के खंड (क) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और राष्ट्रीय अल्पसंख्यक आयोग (अधिकारियों और अन्य कर्मचारियों की सेवा के शर्तें और निबंधन और शर्तें) नियम, 1994 का जहां तक उनका संबंध प्रशासिनक अधिकारी, अनुसंधान अधिकारी, अनुभाग अधिकारी, निजी सचिव और पुस्तकालयाध्यक्ष के पदों से हैं, उन बातों के सिवाय, अधिकांत करते हुए जिन्हें ऐसे अधिक्रमण से पूर्व किया गया है या करने का लोप किया गया है, राष्ट्रीय अल्पसंख्यक आयोग के कतिपय पदों पर भर्ती की विधि को विनियमित करने के लिए निम्नलिखित नियम बनाती है, अर्थात:-

- 1. संक्षिप्त नाम और प्रारंभ (1) इन नियमों का संक्षिप्त नाम राष्ट्रीय अल्पसंख्यक आयोग (अधिकारियों और अन्य कर्मचारियों की सेवा की शर्तें एवं निबंधन और नियम) नियम, 2020 है।
- (2) ये शासकीय राजपत्र में इनके प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. लागू होना ये नियम, इन नियमों से उपाबद्ध अनुसूची के स्तम्भ (1) में उल्लिखित पदों पर लागू होंगे।
- 3. पदों की संख्या, वर्गीकरण और वेतन मैट्रिक्स में स्तर उक्त पदों की संख्या, उनका वर्गिकरण और उनका वेतन मैट्रिक्स में स्तर वे होंगे जो इन नियमों से उपाबद्ध अनुसूची के स्तम्भ (2) से स्तम्भ (4) में विनिर्दिष्ट है।

- G.S.R. 783(E).—In exercise of the powers conferred by clause (a) of sub-section (2) of section 15 of National Commission for Minorities Act, 1992 (19 of 1992) and in supersession of the National Commission for Minorities (Terms and Conditions of Service of the Officers and Other Employees) Rules, 1994, in so far as they relate to the posts of Administrative Officer, Research Officer, Section Officer, Private Secretary and Librarian, except as respect things done or omitted to be done before such supersession, the Central Government hereby makes the following rules regulating the method of recruitment to certain posts in National Commission for Minorities, namely:
- 1. Short title and commencement. (1) These rules may be called the National Commission for Minorities (Terms and Conditions of Service of Officers and other Employees) Rules, 2020.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application. These rules shall apply to the posts mentioned in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classification and level in pay matrix. The number of said posts, their classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule.
- 4. Method of recruitment, age-limit, qualifications, etc. The method of recruitment, age-limit, qualifications and other matters shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 5. Initial Constitution. The incumbent holding the post of Principal Private Secretary in the National Commission for Minorities on regular basis, on the date of commencement of these rules, shall be deemed to have been appointed under these rules to the corresponding posts mentioned in the Schedule and the services rendered by him in the said post shall be taken into account for the purpose of probation, qualifying service for promotion, confirmation and pension.
- 6. Disqualification. No person, -
 - (a) who, has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts:
 - Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
- 7. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.
- 8. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided to the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
