#### 8. Conditions:

- (1) Quotations received without EMD of Rs. 5000/- will not be accepted. EMD of unsuccessful bidders will be returned after finalisation of the bid and EMD of the successful bidder will be returned after successful completion of work.
- (2) No compromise on the quality of paper/colour will be allowed and if sub-standard quality/colour is found, the work will be rejected and the firm will have to supply a fresh lot. If the above specifications are not followed in toto and delivery not made on time, penalty will be levied by the NCM depending on the variation and EMD will be forfeited. The discretion of NCM in this regard will be final and binding.
- (3) All pages of tender documents must be signed by the bidder.

- (7) Complete printing material in CD (in both English as well as Hindi version) has to be provided to NCM along with the Bill.
- (8) The price offer being made by the firm should be in separate sealed envelope. The other documents may be in another sealed envelope and both may be submitted in a bigger envelope.
